#### **Prosecutor** admits to bridge attack

A prosecutor who was walking drunk through traffic on the Brooklyn Bridge and choked and punched a female EMT who came to his aid in November pleaded guilty to reckless assault yesterday in Manhattan.

Michael Jaccarino 30, who worked in the Brooklyn district attorney's office, was sentenced to 10 days community service and six months of alcohol treatment. He is due in court April 16 to show proof of compliance.

Jaccarino, already in treatment, remains on "indefinite suspension without pay." His attorney, Gary Farrell, told the court he was sure Jaccarino will lose his

TSA probing report the couple boarded without security check

Kim Kardashian and Kanye West boarded a flight at Kennedy Airport on Tueswithout going through security screening, a law enforcement source said.

The breach of security regulations delayed the flight by nearly an hour and prompted a TSA investigation of an airline employee.

The American Airlines worker escorted the pair through a nonpublic area and onto a flight to Los Angeles in violation of TSA protocols, the source said.

The agency said in a statement that the passengers, whom it did not name, arrived at Kennedy on a flight from Rio de Janeiro and cleared U.S. Customs and baggage recheck.

Then the airline employee took them through a nonpublic area to provide "expedited access" to their domestic flight.

West and Kardashian were allowed to board the flight without going through a TSA security checkpoint, the TSA said.

Officers subsequently removed the couple from the flight and screened them in the jetway, the TSA said.

### **Ex-Qns. senator pleads guilty**

Former Queens State Sen. Shirley Huntley pleaded guilty to falsifying evidence to cover up a \$30,000 theft of taxpayerfunded grant money given to her fraudulent nonprofit, state prosecutors announced yester-

Members of the Parent Workshop, the ex-senator's nonprofit, pocketed nearly \$30,000 in taxpayer grant money given to the organization. Huntley admitted that, after learning of an investigation into the theft, she created

a fake letter saying services were performed using the money

Two weeks ago, Huntley also pleaded guilty in Brooklyn federal court to embezzling more than \$87,000 in taxpayer money through the Parent Workshop. She faces up to five years in prison and a fine of \$250,000

In light of her federal plea, state prosecutors recommended a sentence of five years probation in exchange for a felony guilty plea. (ANNA SANDERS)
